was our own Country Lane Memory. The awards were sponsored by Springfield Business Journal and United Community Bank.



#### • Fiber Update from CASSCOMM

CASSCOMM is currently working on updating our plant to offer Fiber to business and home services. This service will bring you



Internet speeds up to 1gig if you choose. Our current Internet packages offer speeds of 10 Meg, 25 Meg, and 50M. Once construction is complete and we connect the customer with fiber, we will be offering Internet packages with symmetrical speeds of 60 Meg/110 Meg/225 Meg and 1 gig. These speeds offered in your current package will be upgraded to the new Fiber speeds. For example, if you currently have 10 Meg you will be bumped up to 60 Meg, if you have 25 Meg you will be moved to the 110 Meg speed. Our construction crews are working as fast and hard as they can to get these services ready. We are over 50% done with our construction process but have not started splicing yet, we hope to be installing customers by the end of the year. We are working hard to get the services updated and ready to go for you.

Also, another wonderful piece to this fiber to the home rebuild is that not only will you be able to get higher fiber optic Internet speeds and VoIP phone services, but we are also launching a new TV platform. This platform will replace our current Technicolor/Cisco boxes and will run thru fiber optics. It is called IPTV.

Here are some of the new IPTV features and services:

- ManageMyTV's App Turn your iOS or Android devices into a remote control.
  You can manage your recordings and view guide data remotely.
- *What's Hot App* Shows you the top programs being watched, the top recordings and the top series recordings in your area.
- *Cloud DVR* Save your recordings in our Cloud rather than on a DVR set top box in your house. Access those recordings from any IPTV box on your account.
- Restart TV Is available with DVR service and gives you the ability to restart a program that is already in progress. If you are browsing channels and see a program that you would like to watch, but it has already started, then you can restart it and watch it from the beginning.

Other IPTV features include guide customization, parental controls, the Games App, the Weather App and Video On Demand services. Customers will receive the first 2 IPTV boxes at no charge. Every IPTV box after that will be an additional \$3.95 monthly charge. Please do not hesitate to contact Casscomm should you have any questions or inquiries. #### Member Feature 65 Years of Service Sherman Fire Protection District 1954 to 2019 Celebrating Our Past – Protecting Your Future



**OUR PAST** - The Sherman Fire Protection District is celebrating its 65th year of service. Efforts to organize a volunteer fire department began on May 20, 1954. On June 30, 1954, residents began making solicitations for support and cash donations which totaled \$1,042 by July 15 of that year. The first official meeting of the Sherman Volunteer Fire Department was held during October 1954.

Equipment for the new department was acquired from several sources. The original tank was purchased in St. Louis. The tractor and the engine to run the pump were donated by local residents, the pump by Standard Oil Company, and the hose by the State of Illinois. The siren was ordered for the truck and the red light was purchased from the Springfield Fire Department. Parts for the pump, the starter for the engine and auxiliary pump were purchased elsewhere. A ladder, helmets and fog nozzle were donated by the Sherman Athletic Club. The Department's first fire house (which is now the Animal Health Center) was erected in 1957. All labor on the building was donated by the citizens of the community, with the fire house dedication May 20, 1957. Fund raising dinners and donations kept the department running until September 1960, when the Sherman Fire Protection District was established.

To meet the needs of a growing community the District's next station, located at 210 East Andrew Road (HSHS Medical Clinic), was started in 1974 and was dedicated July 20, 1975. Less than twenty years later, increases in the district's population once again required that the District relocate to larger quarters. The Board of Trustees started the financing and planning process for the current structure, located at 2215 East Andrew Road, in 1993. Steckle-Parker of Springfield, IL was the architect for the project and MACO Construction, of Carlinville, the general contractor. This 10,000 square foot facility was dedicated July 9, 1994.



**THE PRESENT** - The Sherman Fire Protection District is now 65 years old. Our roster of approximately 24 members are highly trained. They are State certified as Basic Operations Firefighters, Emergency Medical Technician (EMT) Basic (EMT-B), Intermediate (EMT-I) or Paramedic (EMT-P) levels; as well as state certified at the Hazardous Material Operations level.

The District is approximately 50 square miles in size and provides fire protection, rescue, and medical (BLS non-transport) to approximately 8,500 persons in the Village and northern Sangamon County. The District is a member of Mutual Aid Box Alarm System (MABAS) Division 48 and supports statewide deployments during disasters. In 2018 the District responded to 544 emergency calls, and it is anticipated we may reach 600 calls in 2019.

As we celebrate the 65<sup>th</sup> anniversary of the Sherman Fire Protection District we are grateful for the community support we have received throughout the years and those many dedicated firefighters and trustees that have served before us.

**REMEMBER VOLUNTEERS ARE NEEDED!** If you have interest in serving the community, consider joining our volunteer fire district. It is because of this volunteer spirit that we can continue the tradition of: "*Celebrating Our Past – Protecting Your Future.*"

# Get to Know Your Public Officials



#### Todd Masterhan – Sherman Fire Chief

Chief Masterhan joined the Army after graduating from Kirkwood High School in Cedar Rapids, Iowa. For the next 14 years he held various military ranks. Each promotion came with increased responsibilities. Todd left the service with an Honorable Discharge reaching the rank of Staff Sergeant.

Upon leaving the military he worked for a Department of Defense contractor providing fire protection to the Iowa Army Ammunition Plant in Burlington Iowa. He reached the highest available rank of Fire Officer while serving that facility. Chief Masterhan is a graduate of the Department of Defense Fire Academy and has endeavored to further his continued leadership, fire/rescue, and emergency medical services training. He has maintained his Emergency Medical Technician-Paramedic certification in four states for over 30 years.

On May 15, 2012, Todd was appointed Chief of the District by the Board of Trustees. Since his appointment, Chief Masterhan has worked to ensure the District keeps its ISO 4 rating (Insurance Service Organization) and hopes to improve the rating. He has been instrumental in retaining the District's volunteer work force and implemented a shift work program that increases emergency coverage in the community. Finally, because of Chief Masterhan's direction the District's public outreach program (tours, open houses, and various social media formats) has kept the community informed about their District.

Chief Masterhan resides in the western part of the Fire District with his wife Lorie.
